FIRE SAFETY CERTIFICATE

Certified that the Cosmos Public School located at Vasundhara Enclave, Dallupura, Delhi -110096, building comprised of basement (Store), ground plus three upper floors only, owned/occupied by Cosmos Public School was issued Fire Safety Certificate vide letter No. F6/DFS/MS/School/NDZ/2021/796 dated 29/09/2021 (Two blocks, One for Ground floor only & Second for ground plus first floor). Now the school building (basement, ground plus three upper floors) was re-inspected by the officer concerned of this department on 11/09/2024 in presence of Dr. Chhalesh Chand (Principal) & Mr. Prince (PTI) and observed that all the fire prevention and fire safety arrangements provided in the premises found in good working condition. The premises have therefore deemed complied with rule 33 of Delhi Fire Service Rules, 2010 and that the building is fit for occupancy class "Educational Building" (Group - B) for ground plus three upper floors only with effect from 07/10/2024 for a period of three years in accordance with rule 36 unless renewal under rule 37 or sooner cancelled under rule 40 and subject to compliance of the conditions under rule 38 of the DFS rule 2010.

Conditions for the validity of Fire Safety Certificate

- 1. Fire Safety Certificate is valid for ground plus three upper floors only.
- 2. The owner /occupier shall apply for renewal of this fire safety certificate to the Director in form J' [sub rule (1) of rule 37] along with a copy of this certificate, six months prior to its expiry
- 3. All the means of escape shall be kept free of all the type of obstruction all the time.
- 4. All the employees shall be acquainted with the use and maintenance of all fire equipment's and method of smooth and speedy safe evacuation of occupants in case of emergency.
- 5. All the firefighting equipment's shall be maintained in perfect working condition all the time and any lapse rendering non-functional of fire safety measures, management shall be responsible.
- 6. The clarification with regards electrical installation, ventilation, structure stability set back areas, occupancy and constructional deviation in building etc. may be got verified from the authorities concerned.
- 7. This Fire Safety Certificate cannot be treated in any case for regularizations of unauthorized construction unauthorized use of land if any.
- 8. At the time of inspection basement is being for store purpose only.
- 9. The owner / occupier shall submit a declaration every year in form 'K' provided in the first schedule of Delhi Fire Service Rule 2010. The form is available on www.dfs.delhigovt.nic.in.
